



Power of 10

Purpose:

The Power of 10 Leadership Academy is an OVMA benefit designed to assist recent graduates in developing a foundation of skills in leadership, communication, and business. The Power of 10 Leadership Academy will also provide learning experiences to enrich the individual, the individual's practice, community, and the profession.

How It Works:

Ten participants will be selected to participate in the Power of 10 Leadership Academy. These individuals must have graduated from a college of veterinary medicine within the last ten years. The OVMA will host five leadership development sessions commencing in July and culminating in January 2018. The OVMA will provide topic experts and meeting expenses at no charge for participants. These sessions will not only develop leadership skills and create a deeper understanding of related topics but will also create lasting bonds with other members of the leadership academy class.

In person learning experiences will be held during the weekday at no cost to the participants with meals and snacks provided. Each participant will be responsible for their own travel expenses. These sessions are eligible to be used towards 6 hours* of CE credit.

Key Benefits:

The academy is designed to develop leadership skills, personal brandings, and emotional intelligence. It is also useful for gaining the competency to use these skills within ones' practice, life, and community. The academy will heighten awareness of one's self and better understand how to maximize interactions with those around you. Participating in this leadership academy will provide a supportive environment to create meaningful relationships and lifelong interactions. All while building a strong network within the Oklahoma veterinary community.

Facilitator:

Dr. Yalonda Burton will be the facilitator for the 2017 Power of Ten Leadership Academy. She completed the program in 2012 and runs a mixed animal practice in Stilwell, OK. She served on the OVMA Board from 2012 – 2016 as District Director, Vice President, President-Elect, President, and Past President.
